Subject: Revision of GST rate from 12% to 5% with effect from 22.09.2025 and Generation of Invoice for September 2025.

Reference: 56th Meeting of the GST Council dated 03.09.2025

Dear Sir/Madam.

Greetings from IMAGE [IMA Goes Eco friendly]

This is to inform you about an important update concerning the generation of invoices for the month of September 2025, in light of recent changes announced by the GST Council.

As per the 56th GST Council recommendations, the GST rate on services related to the collection, treatment, and disposal of biomedical waste has been revised from 12% to 5%, with effect from 22 September 2025.

Since biomedical waste disposal is classified as a continuous supply of service, and the September billing period spans the date of this rate change, we will be splitting the invoice pro-rata based on the number of service days, as follows:

- 01 September 2025 to 21 September 2025 → GST applicable at 12%
- 22 September 2025 to 30 September 2025 → GST applicable at 5%

This method ensures compliance with GST provisions and accurately reflects the applicable tax rate for the respective service periods.

We request your attention to this matter and your cooperation in ensuring smooth processing of the upcoming invoice.
